This summer we served more than 1,000 campers. Eight of the nine sessions offered served children with cancer, sickle cell anemia, metabolic disorders, HIV/AIDS, and other blood diseases. Our final session of the summer invited the healthy siblings of the previous summers' campers to attend Camp and enjoy the same experience that their sick brother or sister shared. They remember the same wonderful counselors, relive memorable day and evening activities and sing together their favorite Camp songs. It remains a very healing experience for the entire family.

Throughout the rest of the year we will continue reaching out to additional children and families battling illness. In so doing we invite new networks of support and understanding to strengthen our participants long after their Camp experience. And, in addition to eighteen weekend programs in the fall and spring, our Hospital Outreach Program brings the same healing through friendship to children at their bedsides in hospitals throughout New England and New York City. In all, 17,500 children with serious illnesses will be served by our programs this year.
