November Educational Program

This year's speakers are Jennifer Cox, Esq. and Lisa Goldstein, Esq. from MGMA. Ms. Cox will begin the program by presenting a year in review including newly enacted regulations and laws, and major cases and trends over the past year that will affect physician practices in Connecticut. This will include changes to PA supervision, CME requirements, professional rehabilitation assistance programs, HMO litigation, a medical liability update, and informed consent. She will also discuss three other hot topics: 1. HIPAA security audits (the Government is on the move); 2. Understanding EMR/IT sharing rules including fraud and abuse and tax considerations; and 3. Possible downstream ramifications from the growth of no-pay quality indicators.

After lunch, Ms. Goldstein will present the "Washington Update" which will include timely information on the status of Medicare administrative simplification, Medicare reimbursement and fraud and abuse compliance. The presentation will also address other hot topics under consideration by Congress and federal regulatory agencies. Attendees will discover recent regulatory and legislative developments affecting medical groups, understand recent changes in Medicare reimbursement and program policies, recognize the implementation status and upcoming issues of HIPAA compliance, and distinguish how federal regulations (including self-referral laws and HIPAA) govern day-to-day activities of medical group practices and what resources are available to clarify these federal initiatives.
