I-95 (North or South) to I-91 North. Exit 15 (Durham-Yalesville). Left off Exit onto Rt. 68W. Proceed 2.2 Miles (6 lights) to Rt. 68 overpass (Rt. 5 directly under overpass). Turn right on Off Ramp. At the end of the ramp, turn left onto Rt. 5. Villa Capri is 1/4 mile on the left side.

**Traveling South I-91**

Exit 15, take a right off the exit onto Rt. 68. Proceed 2 Miles (5 lights) to Rt. 68 overpass (Rt. 5 directly under overpass). Turn right on Off Ramp. At the end of the ramp, turn left onto Rt. 5. Villa Capri is 1/4 mile on the left side.

**Traveling North or South on the Merritt or Wilbur Cross Parkway (Rt. 15)**

Exit. 66. Turn left at end of the ramp onto Rt. 5. Villa Capri is 3/4 mile on the left side.

**Rt. 86 from Boston**

To Rt. 84 West to I-91 South. Follow directions above from I-91 S.

**Rt. 84 from Danbury**

East Rt. 84 to Exit 27 (Rt. 691) to Exit 10 to the Merritt/Wilbur Cross Parkway Exit 66. Turn left at the end of the ramp onto Rt. 5. Villa Capri is 3/4 mile on the left side.

I-95 South to I-91 North. Follow directions above to I-91 North.
